

Accreditation Committee Annual report 2023/24

Chair's introduction

In accordance with its Charter, the Accreditation Committee (the Committee) provides this annual report to the Ahpra Board for its consideration and publication on the Ahpra website. This is the Committee's third annual report and covers its activities for the period 1 July 2023 to 30 June 2024.

The Committee was established in September 2021 following Policy Direction 2020-1 issued by the Ministerial Council. The Committee's membership has been drawn from a broad range of accreditation stakeholders.

I am pleased to advise the Committee has made significant progress on its workplan deliverables over the past 12 months. In October 2023, the Committee published its first deliverable – the glossary of accreditation terms, which is designed to create a shared understanding of the terms used in the Committee's guidance among stakeholders.

In March 2024, the Committee published its interprofessional collaborative practice (IPCP) statement of intent. The statement represents a joint commitment from 53 stakeholders across the health and education sectors to take action and embed IPCP across the Australian health system, in education, training, clinical governance, research and practice. The statement is a fundamental step towards achieving effective team-based and coordinated care across Australia. It is a commitment to improving the outcomes for patients and consumers by reducing the risk of fragmented and uncoordinated care.

The committee has also undertaken preliminary and public consultation on draft principles for strengthening the involvement of consumers in accreditation and its draft guidance on embedding good practice in clinical placements, simulation-based learning and virtual care in initial student health practitioner education. It is expected that both key pieces of work will be finalised and delivered by the end of 2024.

The Committee has also continued to focus on reform in light of current health workforce pressures and how it can deliver solutions in the accreditation context. The Committee's priority areas for reform include:

- continuing the focus on outcome-based approaches to accreditation, to enable education providers to respond to changes in community need and innovations in health practice
- enhancing efficiency in the development of professional capabilities and in accreditation standards and processes
- · reducing duplication and areas of overlap between accreditation authorities and education regulators

The Committee is well on track to deliver many of its other deliverables over the next 12-months.

Thank you to Committee members and Ahpra staff members for their contribution to the Committee's work.

Role of the Committee

Consistent with the Ministerial Council <u>Policy Direction 2020-1</u>, the Accreditation Committee provides independent and expert advice on accreditation reform and other National Scheme accreditation matters to National Scheme entities such as National Boards, Accreditation Authorities and Ahpra.

Functions and responsibilities of the Committee

The Committee's function and responsibilities have included, but are not limited to:

- preparing independent and expert advice on accreditation reform and other National Scheme accreditation matters to National Scheme entities
- support implementation of Health Ministers' February 2020 response to the recommendations of the Independent Review of Accreditation Systems Final Report (ASR Final Report)
- provide a forum for advice on significant whole of Scheme accreditation issues including governance, accountability and transparency issues, and
- provide jurisdictions and relevant stakeholders with information on how National Scheme entities and relevant external entities are taking the Committee's advice into account.

Powers of the Committee

The Committee has no formal delegated power from the Ahpra Board. The Policy Direction's intent is that Ahpra, National Boards and Accreditation Authorities are accountable for having regard to the Committee's advice when exercising their functions under the National Law.

Membership

Membership is appointed by the Ahpra Board and consists of:

- an external accreditation/education expert
- nominee of the Australian Commission on Safety and Quality in Healthcare
- nominee of the Tertiary Education Quality and Standards Agency
- nominee of Universities Australia
- two nominees of the Health Professions Accreditation Collaborative Forum
- two members of the Ahpra Board
- two National Board representatives
- jurisdictional representative
- private healthcare employer
- consumer/community representative
- two members who identify as an Aboriginal and/or Torres Strait Islander person

As mandated in the Committee charter, the Chair of the Committee (Professor Andrew Wilson AO) is independent (that is not a member of the Board; an office bearer, employee or agent of any nominating body; or an office bearer, employee or agent of any National Board, Accreditation Authority or Ahpra). Professor Maree O'Keefe is appointed Deputy Chair, noting she has a similar level of independence as the Chair.

- final guidance on embedding good practice in clinical placements, simulation-based learning and virtual care in initial student health practitioner education, together with case studies to assist those responsible for implementing the guidance
- final principles to clarify the roles of National Scheme entities and TEQSA in the accreditation of health practitioner education
- final good practice guidance on developing professional capabilities
- final guidance for accreditation authorities on the use of outcome-based approaches in accreditation
- an implementation plan on the National Scheme interprofessional education and interprofessional collaborative practice statement of intent
- advice to National Scheme entities on the publication of accreditation assessment decisions and monitoring reports.
