R9: Endorsed registrants by endorsement type

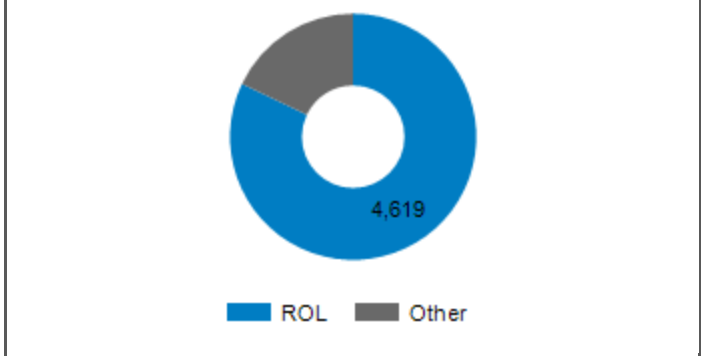

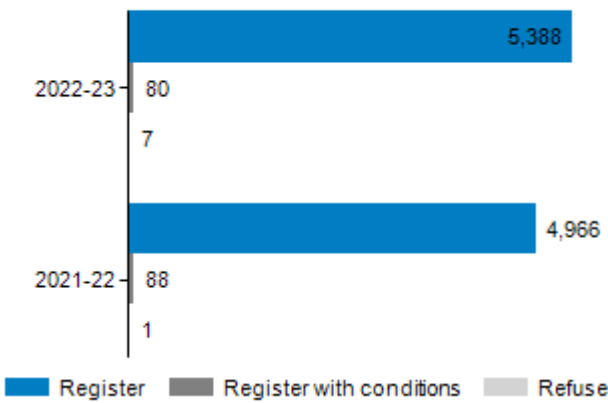
A6: Applications received by applicants PPP



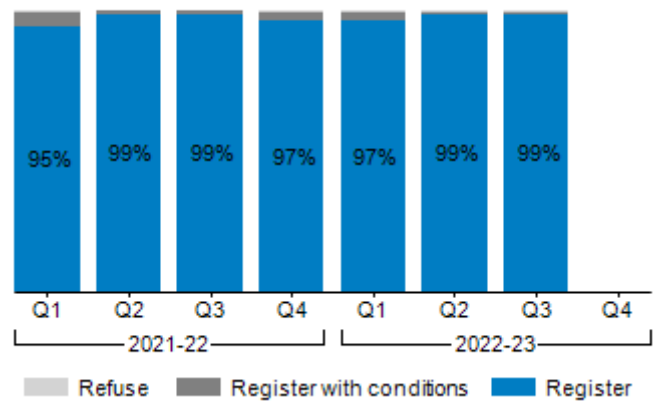
A7: Applications received by applicant type



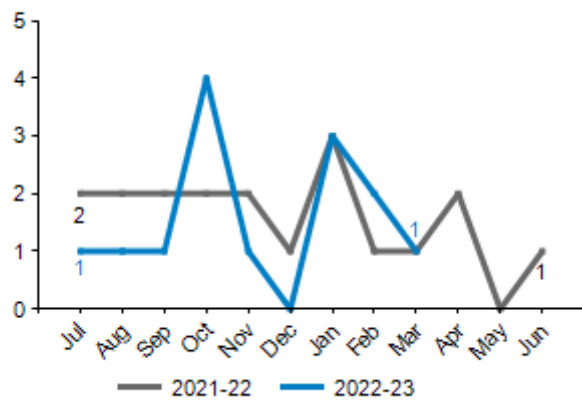
A8: Outcome of finalised applications



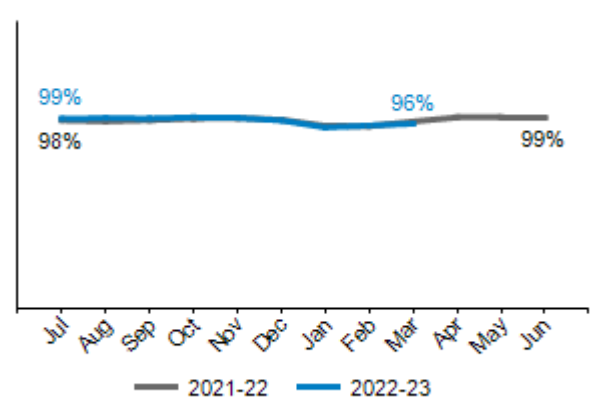

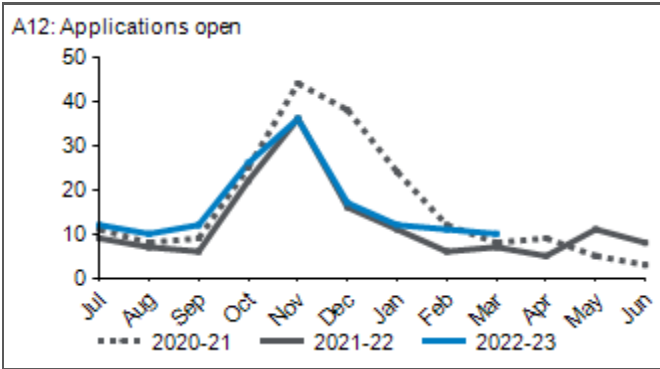
A10: Median time to decide applications



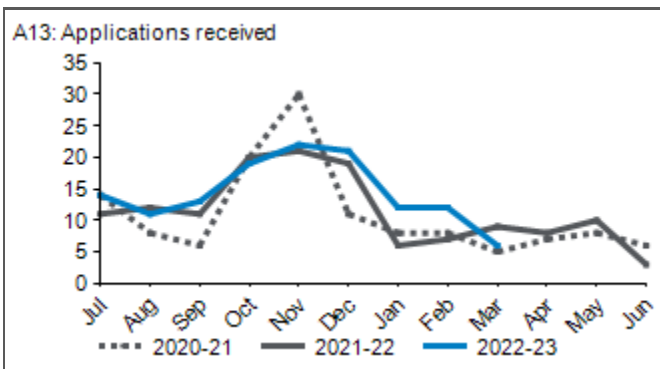

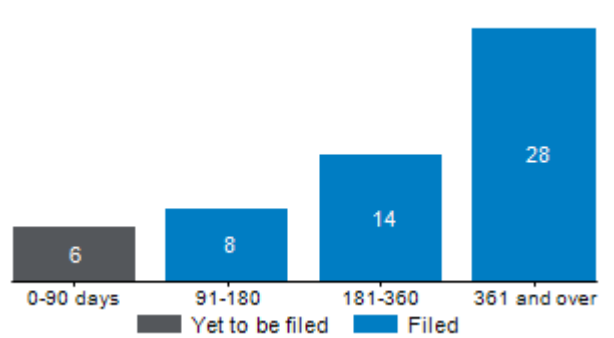
L6: Age of open tribunal matters



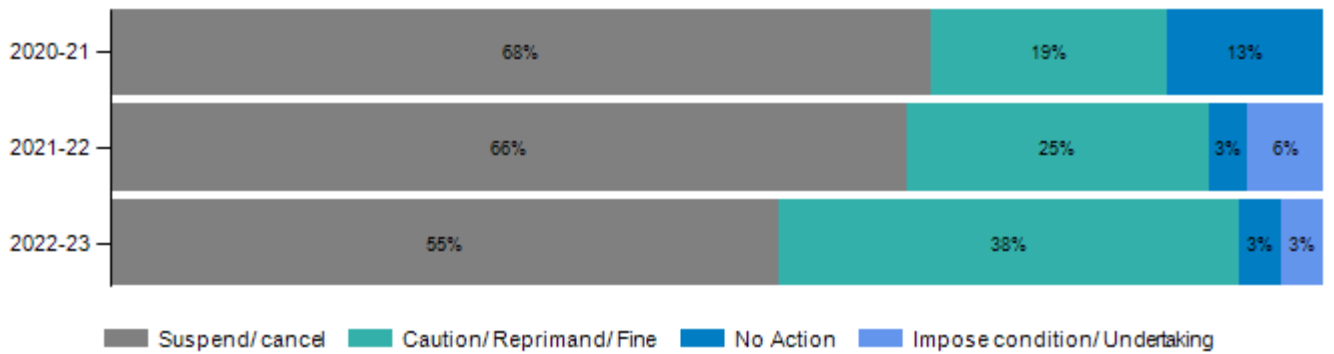
L7: Open tribunal matters by timeframe



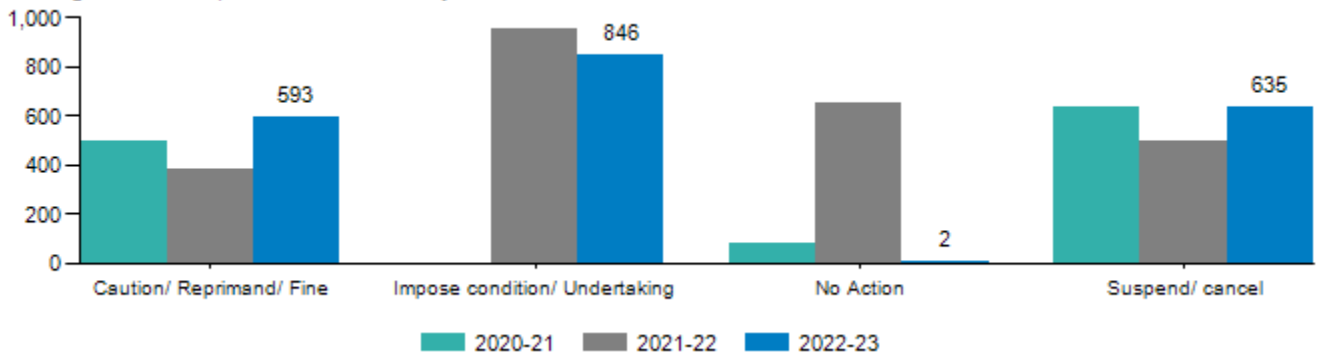
L8: Open tribunal matters by timeframe & filing status

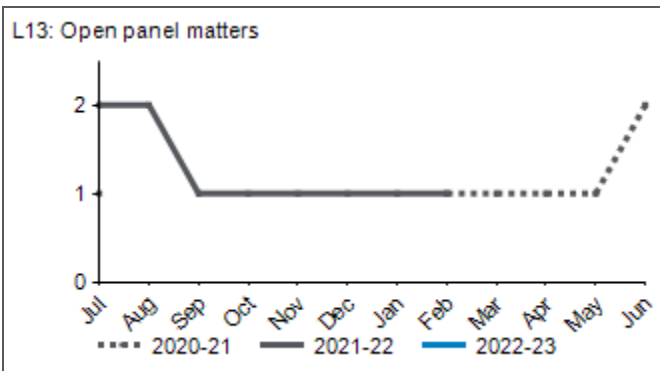
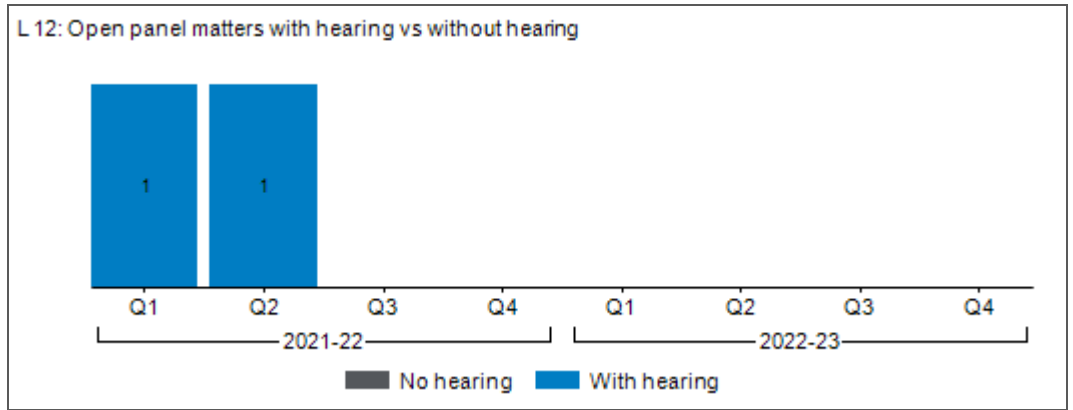


L10: Average time to complete tribunal matters by outcome

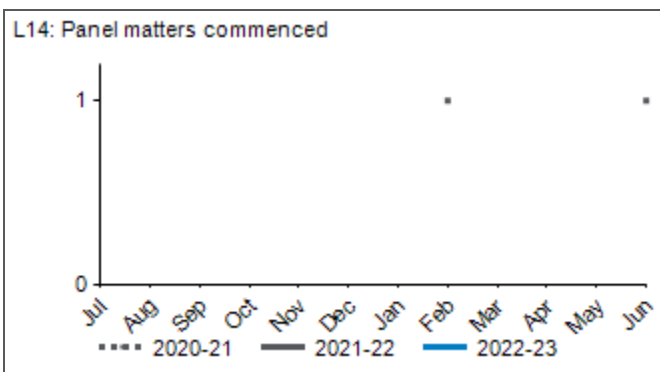

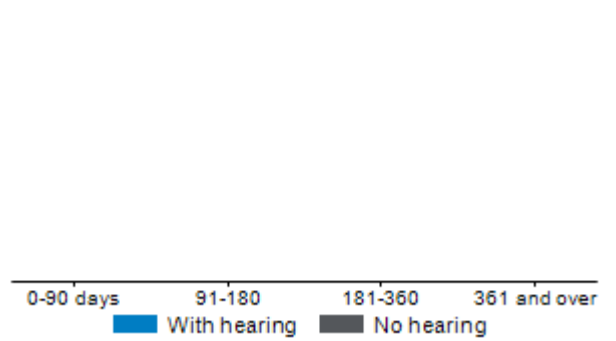
L16: Age of open panel matters



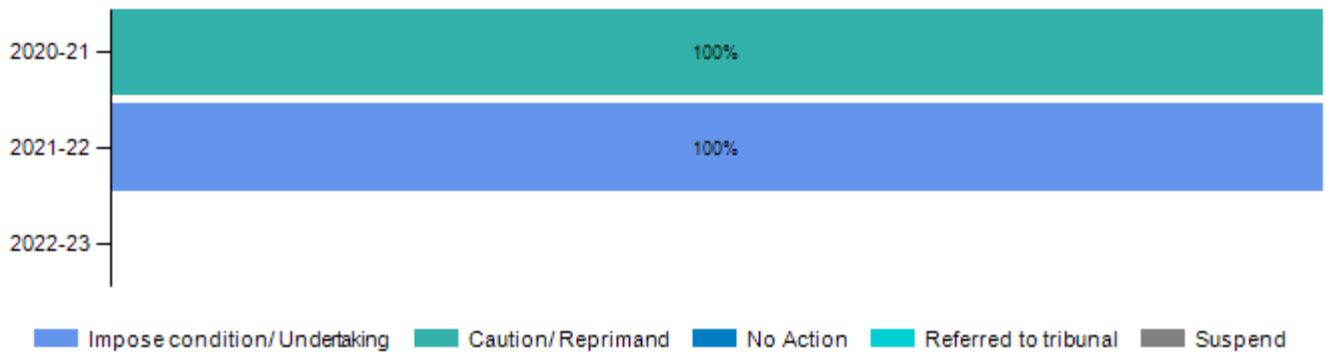
L17: Open panel matters by timeframe



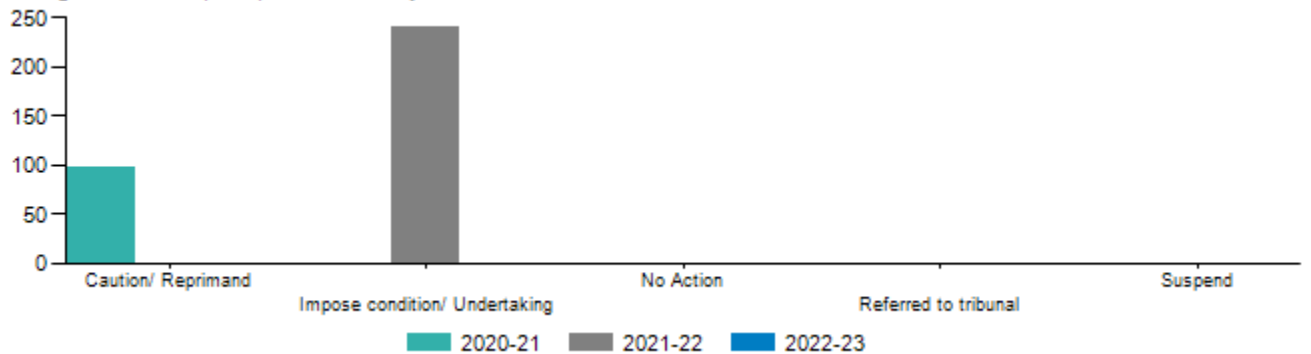
L18: Open panel matters by timeframe & hearing status



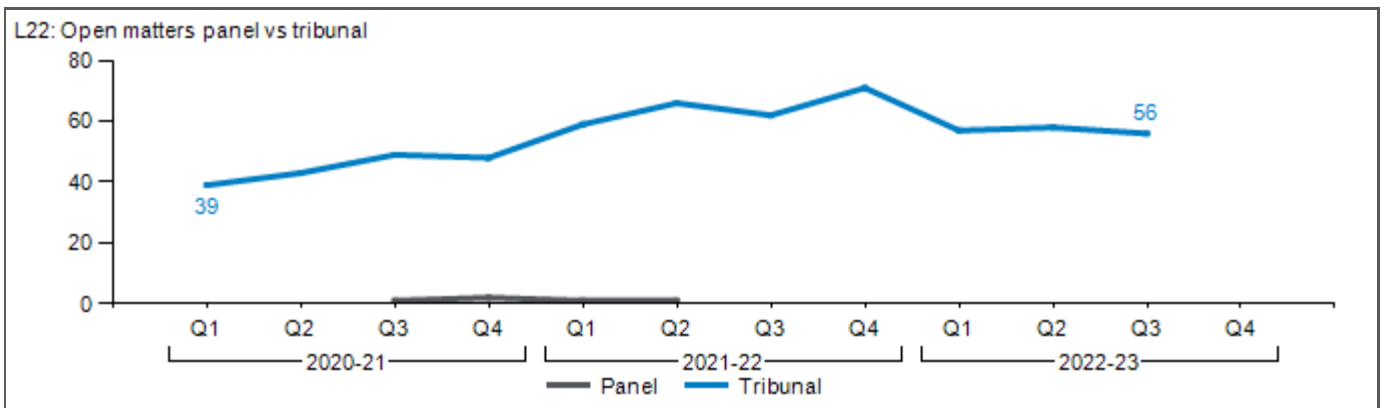
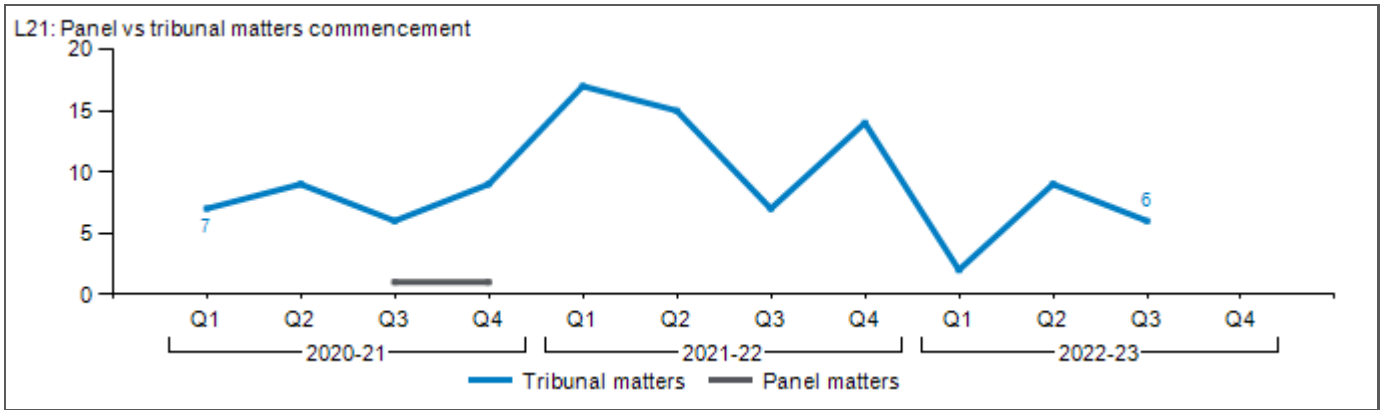
L19: Panel matters completed by outcome, year by year



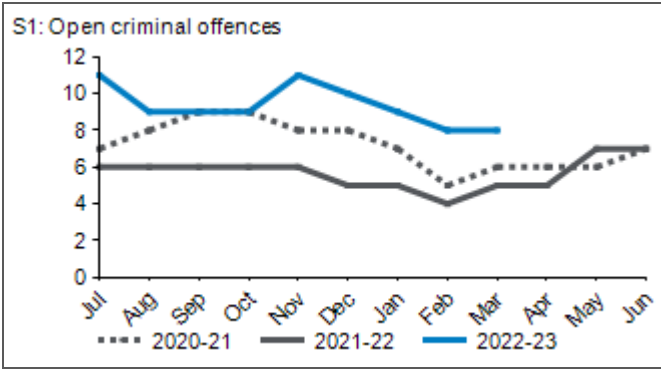

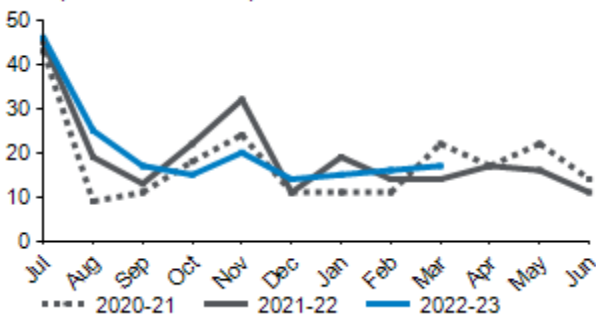


MC3: Compliance cases commenced



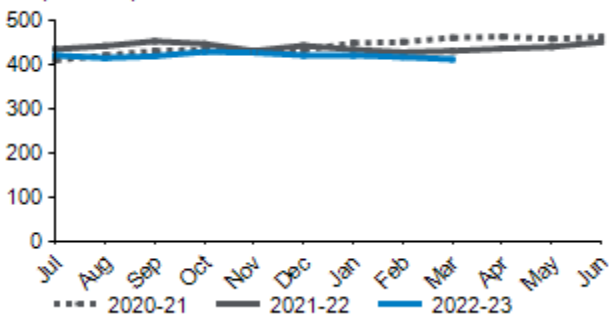
