

# Regulatory Performance Committee Annual Report 2019/20

# **Chair's introduction**

The work of the Regulatory Performance Committee during 2019/20 focused on embedding the regulatory performance reporting framework. The quality, accuracy and completeness of performance reporting is an important ongoing focus in the overall governance and management of the National Registration and Accreditation Scheme. Performance reports and dashboards continue to be streamlined as the framework continues to develop. Publishing of external quarterly performance reports continues to provide the public with information on the activities and performance of Ahpra and the National Boards in each state and territory.

Throughout the year the Committee considered a number of quality reviews as well as the overall annual work plan. The quality reviews provide a comprehensive overview and analysis of specific aspects of our regulatory performance. The June 2019 to July 2020 period included the registration plan for resourcing the peak registration period and the work being progressed on implementing notification assessment practices in line with risk-based principles.

The last quarter of the annual reporting period saw the committee focused on the impacts of COVID -19 on regulatory functions and the response of Ahpra and the National Boards.

Thank you to Committee and Ahpra staff members for their contribution to the work of the Committee.

### **Role of the Committee**

The Regulatory Performance Committee (the Committee) is a committee of the Agency Management Committee (AManC). The Committee has been established to provide advice on the following areas:

- strategic regulatory operational policy informed by Ahpra and the National Boards
- risk settings and management, including mitigation strategies and triggers for action and escalation
- Ahpra's regulatory performance and strategies of addressing policy and performance issues regulatory performance reporting to National Boards and external stakeholders.

### Functions and responsibilities of the Committee

The Committee's function is to:

- provide oversight of Ahpra's management of regulatory performance, including registration, notifications and compliance matters
- provide advice on regulatory performance measures and Key Performance Indicators on timeliness, cost and quality
- review Ahpra's quarterly performance reports for registration, notifications and compliance and provide advice to the Board and National Boards on regulatory performance
- provide a forum for discussion, review and advice on significant issues of regulatory operational policy

### Powers of the Committee

The Committee has no formal delegated power from the Board. The Committee functions in an oversight and review role and makes recommendations to the Agency Management Committee.

### Membership

Membership is appointed by the AManC and consists of:

- Up to four members of the Board
- At least five chairs of National Boards (including the high-volume Boards), and
- A community member of a National Board

In addition, meetings will be attended by:

- Ahpra CEO
- Ahpra Executive Director, Regulatory Operations
- Ahpra senior management, as and when required.

The Committee Chair is appointed by the Board and must also be a member of the AManC. All members are appointed by the AManC for a term not exceeding three years. Members may be re-appointed for two additional terms.

# **Reporting to the Agency Management Committee**

## Committee activities for reporting period 1 July 2019 – 30 June 2020

Continued to embed the regulatory performance reporting model and the streamlining of reporting dashboards

- Considered the internal review of the 2020 graduate registration campaign (including the first ever survey of registrant experience)
- Consideration of the registration plan (including graduate registration campaign) for resourcing the peak registration period
- Monitoring progress against the Notification Think Tank outcomes
- The use of monitoring plans in preparation for transition to the national operating model for compliance
- Reviewing Notifier and Practitioner Engagement Dashboard reports
- Implementation of regular reporting of Administrative Complaints
- Consideration of the Performance Report: Medicare Data and National Pathology Service
- Noted the Deloitte internal audit health check of risk-based methodology evaluating the implementation of the risk-based methodology for prioritising notifications
- Consideration of the performance review of monitoring of aged restrictions (imposed more than two years ago) by National Compliance
- Review of the Committee Terms of Reference
- Quarterly reporting on performance to the Agency Management Committee.
- Considered and provided feedback on lessons learnt from the implementation of national regulation of the Paramedicine profession
- Considered and provided feedback on source of notification data

## **Significant issues**

- There were no significant issues considered during the 2019/20 reporting period which could not be handled through routine Committee procedures
- Matters of note considered by the Committee included:
  - the impacts of COVID -19 on regulatory functions
  - the impact on registration performance of the transition to the national operating model
  - the continued increase in the rate of new notifications received

## Looking ahead

The Committee have highlighted the following key areas:

- the importance of developing a strategy for notifications for 2025 and beyond, in addition to the work Ahpra is undertaking to respond to the demand in the medium term
- the work being progressed on implementing notification assessment practices in line with risk-based principles
- continued work to build a positive reporting and measurement culture within Ahpra
- improving data analysis and insights which accompany performance reports
- streamlining and consolidating performance reports
