As at 30 June 2023 there were 877,119 registered health practitioners in Australia.



Know who you're seeing about your healthcare

You can check our Register of practitioners to see if someone is registered and whether there are any special requirements on their registration. You can search by their name, profession, postcode, gender and/or language spoken.

You can access an interpreter

If you are a non-English speaker or find it easier to speak in your own language you can contact Ahpra via a free interpreter by calling **131 450** and asking them to call Ahpra on **1300 419 495**. Eliminating racism and cultural safety in healthcare

Aboriginal and Torres Strait Islander ways of being, knowing and doing guides the National Scheme's Aboriginal and Torres Strait Islander Health and Cultural Safety Strategy 2020–2025 work to eliminate racism in the organisation and healthcare.

Ahpra's Aboriginal and Torres Strait Islander Health Strategy Unit (HSU) draws on the Aboriginal and Torres Strait Islander Health Strategy Group, Aboriginal and Torres Strait Islander practitioners, peak bodies, and race scholars to guide its critical work.

The HSU is 100% Aboriginal and Torres Strait Islander staffed, guiding strategy goals to eliminate all forms of racism, systemic, institutional and interpersonal. Its transformative work includes creating a culturally safe notification process for Aboriginal and Torres Strait Islander Peoples making a complaint, Indigenous National Special Issues Committees to review complaints, increasing Aboriginal and Torres Strait Islander representation on Boards, cultural safety training to all staff, board and committee members and an Anti-Racism Policy.
