# 1 Welcome by the Chair

All members were welcomed to the meeting.

# 1.1 Acknowledgement of traditional custodians

The Executive Officer acknowledged the traditional custodians of the country, the people and the water from where participants attended the meeting and paid respects to Elders past and present.

## 2 Presentations

The following information was presented by Ahpra staff, which included matters referred for discussion by Professional Associations:

# 2.1 Advertising requirements in the National Scheme

Members of the Ahpra Compliance team provided a presentation to attendees on the various advertising requirements that the National Law places on practitioners. Attendees were shown examples of the resources specific to Chinese medicine that are currently available on the Ahpra website and informed of the work that is currently underway to update them.

## 2.2 Workforce retention and attrition project (WRAP)

Attendees received a presentation on the Workforce Retention and Attrition Project (WRAP), which examined what drives health practitioners to stay or leave the health workforce. In June 2023, nine National Boards, including the Chinese Medicine Board, agreed to participate in the project. 1,366 respondents identified as Chinese Medicine practitioners (a 24% completion rate for CM). The study asked practitioners what motivates them to stay in their profession and the reasons they are leaving. Factors that predict whether a practitioner will stay or leave, such as work hours, years of experience and / or self-employment, were also examined. A paper detailing the findings has been submitted to a peer reviewed journal and is likely to be published in late 2024.

# 2.3 Chinese Medicine Board Regulatory Examinations

This presentation briefed attendees on the Board's regulatory examination, comprising the multiple-choice questions (MCQ) and objective structured clinical examination (OSCE). The National Manager – Registration shared the process that candidates follow when undertaking the examinations, candidates' country of qualification and other examination statistics and details on the OSCE examinations site.

## 2.4 Accreditation and program approval in the National Scheme

Attendees received a short presentation explaining the purpose of accreditation, how accreditation works within the National Scheme and how Chinese medicine programs are accredited and monitored by the Chinese Medicine Accreditation Committee, independently of the Board.

# 3.1 Update on the Board's work plan

The Deputy Chair gave an update on the Board's work plan:

- Guidelines on patient health records
  - The public consultation on the proposed revised Guidelines on patient health records closed on 5 June 2024.
  - The Board will be considering all feedback in detail and due to the consultation only just closing was not able to comment at the time of the meeting.
- Advertising
  - Updates are being made to guidance specific to Chinese medicine.
- Virtual care
  - The Board will be publishing a set of FAQs online to provide information to Chinese medicine practitioners offering virtual care.
- Public information campaign
  - The Board is working on a campaign aimed at informing the public about Chinese medicine, what constitutes safe practice and the role of the Board.
- Continuing engagement with practitioners and students
  - Newsletters
  - Webinars
  - Presentations
