#### Item 1 Chair's welcome and introduction

The Chair welcomed members to the 17 November 2015 Agency Management Committee meeting.

#### Item 1.1 Apologies for absence

## Item 2 Chair's report

Mr Gorton updated members about:

- A recent meeting with the Victorian Minister of Health, The Hon. Jill Hennessy MP concerning the issues at Djerriwarrh Health Service, our work with the Department of Health and wider actions underway in Victoria.
- Recent engagement with Forum of Chairs and issues discussed, in relation to the NRAS Review and preliminary advice on the future state of National Boards.
- A recent meeting with Ms Penny Armytage, KPMG, concerning a review of AHPRA's notifications systems and processes in Victoria.
- A meeting with Ms Barbara Yeoh, Chair, Finance, Audit and Risk Management Committee and representatives from Deloitte to conduct a first stage review of arrangements for managing equity.
- A recent meeting with Dr Marie Bismark, Senior Research Fellow, University of Melbourne, concerning the National Health and Medical Research Council's Project Advisory Group.

Members noted the recent visit by Professor Walton to the UK Professional Standards Authority to carry out research which seeks to compare and contrast the experience of Australian consumers who made complaints to the health regulators with consumers who made complaints to regulators in the United Kingdom (and other developed countries).

Members noted an overview of the status of work being undertaken with the University of Melbourne and with the University of Sydney in partnership with AHPRA and National Boards will be provided.

## Item 3 CEO report

Members noted the CEO report and the update provided by Mr Fletcher including:

- The decisions made by the Australian Health Workforce Ministerial Council (AHWMC) at its recent meeting including options for national registration of the paramedic profession.
- Issues being managed in Queensland (Qld) in relation to reducing assessment timeframes and wider issues in relation to co-regulatory arrangements in place. Members requested information outlining timeframes for referral of matters from the Qld Ombudsman to AHPRA.
- Work underway concerning the investigation at Djerriwarrh Health Service in Victoria and the wider
  work underway in Victoria including the commissioning of KPMG to carry out an independent review
  of notification systems and processes, and planned work with the Australian Commission on Safety
  and Quality in Health Care. Members noted a briefing on findings from the KPMG review will be
  provided to the Committee.

# Item 4.1 Feedback from meeting held on 16 November 2015

Ms Barbara Yeoh, Chair, Finance, Audit and Risk Management Committee (FARM Committee) provided members with a summary of the meeting held on 16 November 2015 including:

- Consideration of the proposed internal audit program for 2015/16. The Agency Management Committee (AManC) approved a recommendation made by the FARM Committee to commence internal audit of:
  - Payroll and Leave Management
  - General Information and Data Security
  - IT capability and readiness,, and
  - Practitioner Conditions Management to commence in the first quarter of the 2016/17 internal audit plan.

Members noted an issues paper developed in conjunction with a working group of National Board Chairs is being considered by National Boards at the November round of meetings. National Board feedback will be considered by the Management Committee at its December 2015 meeting as part of a broader NRAS Review discussion.

Members noted the legal update for October 2015 and requested further assurance concerning outcomes of the review of an identified high risk matter.
