- Clinical nursing experience &/or clinical nursing supervision experience, within Australia for a minimum of five (5), or more, years
- Current clinical nursing practice &/or clinical nursing supervision role
- Ability to attend OSCE examinations that will be held in Adelaide.

The following are the **desirable** examiner skills and eligibility criteria:

- Nursing &/or health professions education experience &/or qualification
- Nursing &/or health professions OSCE examination experience

Examiners will be remunerated for their time.
