Interprofessional collaborative practice	The ADA suggests including the words ' <i>interdisciplinary practice</i> ', ' <i>multidisciplinary practice</i> ' and ' <i>transdisciplinary practice</i> ' as synonyms for the term 'interprofessional collaborative practice' as these words are being used in the healthcare sector interchangeably.
Interprofessional education	The ADA suggests including the words ' <i>interdisciplinary education</i> ', ' <i>collaborative learning</i> ', ' <i>team-based education</i> ,' ' <i>multidisciplinary education</i> ' and ' <i>cross-disciplinary education</i> ' as synonyms for the term 'interprofessional education'.
Person-centered care	The ADA suggests including the words ' <i>holistic care</i> ' and ' <i>shared decision making</i> ' as synonyms for the term 'person-centred care' as these words are being used in the healthcare sector interchangeably.

Simulation-based learning	The ADA suggests including the phrases ' <i>hands-on learning</i> ' and ' <i>practice-based learning</i> ' as synonyms for the term 'simulated-based learning'
